2. The school functions under the rules framed under the Karnataka Education Act 1983 and the Child Rights Education Act 2009
3. Under the rules framed under the Children's Rights Education Act 1983, 25% of the seats are reserved for underprivileged children. There are schools that fall under this category and have made rules that if there are students who have received grants from the government, the children of that school will be enrolled. Continuation Allow these children to continue their studies without any discrimination.
4. As explained in Schedule 3, the fees of the children enrolled under this rule will be disbursed by the Government as per rules. Aadhaar prohibits charging any fee to these children.
5. The school and the governing body have prohibited any form of embezzlement of capitation fees and voluntary contributions by candidates either at the time of enrollment or thereafter.
6. The school/governing body shall not charge any additional fee over and above the prescribed fee by the parents of the children in their school.
7. The school/governing body shall state Admission within a given time period.

- g. Payable bank and other salaries and covered by Employee State Insurance (ESI). As per section 24[1] of Rights of the Child Education Act.
- h. Recruited teachers must possess the minimum qualifications as prescribed for primary and secondary teachers in the RTI Act and Rules and the Karnataka Education Act and Rules and Government Order
11. The school/governing body shall follow the Books as per the University.
12. The school functions under the rules framed under the Karnataka Education Act section admission will be conducted as per the necessary of students
